TERMS AND CONDITIONS

1. That you shall sell a minimum of ten-speed governors by the name GSMART within any given calendar month.
2. That you shall not make or assemble any form of speed limiter or speed recording device and brand it GSMART.
3. That you shall forward, in soft or hard copy daily returns of all jobs done either in fitting of renewal of speed governor and certificate issues and REPORTS generated by viewer by 8 am every morning by email or as maybe directed from time to time.
4. That you shall keep a record (clean) of all governors fitted, serial numbers, IMEI numbers, Simard numbers date fitted, type of vehicle fitted, make of vehicle, name of owner and telephone number and shall keep similar records for all governor renewals/inspections and that all counterfoils shall be surrendered to Greenwich Auto Diesel Limited.
5. That you shall allow impromptu inspections of your records by Greenwich Auto Diesel Ltd.
6. That you shall not be involved in any unethical business and technical practices at all times as spelt out by the relevant authorities and shall not issue a certificate of compliance without physically inspecting the vehicle to ascertain governor type, serial number, IMEI Number and work ability at all times.
7. That you shall not issue a certificate of compliance for speed governor not true to type as may be provided by ministry of transport gazette notice from time to time and shall not issue a certificate for relays put in a box or any other form of container or any governor apart from governors supplied by Greenwich Auto Diesel Ltd.
8. That Greenwich Auto Diesel ltd shall retain the power to cancel agency if the conditions are breached.
9. That each party can give 7 days' notice to terminate the agency contracts with reasons being stated.
10. That you shall aggressively market GSMART as the governor of choice and protect its sanctity all times and shall always give a one-year warranty and that you shall ensure you enforce warranty for one year issued by Greenwich Auto diesel and will return any faulty governor to Greenwich auto diesel by way of registered courier service and Greenwich shall repair the said governor and return it to you in good working condition.
11. That you accept liability for any issues arising from any fitted without being configured and a report not issued to that client.
12. That Greenwich Auto Diesel ltd can amend and vary these terms and conditions without consultation.
13. That these terms take effect from the fist governor installed.
